- Guidelines: A copy is included in the JOLT packet. All guidelines and procedures are based on the Hurst Qualified Operator manual.
- Training: Firematic offers free training to new teams interested in entering the tournament for the first time.
- Entry Includes: Event shirt, \$6,000 (based on 60 entries) plus a Hurst Rescue tool to the winner, lunch on competition day. Team meeting on September 25th, 2008 will be held at Firematic in East Yaphank at 7:00 PM. Special arrangements will be made for out-of-state teams.

The World's best Rescue Teams meet again on September 27th, 2008. This exciting event is a speed and safety contest using Jaws of Life Rescue tools. The contests are between two teams on opposite sides of one vehicle. The participants are timed for the particular evolution. At the same time judges are scoring penalties for safety infractions. The low combined time (safety and speed) advances to the next round, and so on until the J.O.L.T. 2008 champion is determined.

## **Quick Facts**

---

- Your team will be met at the on deck circle, and you will have three minutes to put your tool inventory in the exercise action area
- No equipment is to be hooked up until the judge starts time clocks
- Start judge will alert team when to begin
- An authorized Hurst technician will start all power units
- Two judges will be timing and scoring
- You will complete your evolution (ex. door, third door, and dash displacement)
- At breakdown you are to return all tools as found to your staging area
- Clock will be stopped when all tools are back in the staging area and in proper order as per your teams safety officer
- When the clock is stopped, you are to return the tools to the inventory area
- The SS judge will then give you a one minute critique before you head to the medical tent for clearance
- Team captains must notify judges of malfunctioning equipment
- Next team up shall be ready to go as soon as equipment is returned to the inventory area
- Score sheets will be given to the head judge for totaling
- The advancing teams will be announced and posted
